- 2. <u>Legislation Update:</u> Bill 7013 passed. The main impact to the district is the 12-year term limits and annual reporting to the state.
- 3. <u>Attorney Selection/Discussion:</u> Included in the packets are proposals from two of the 4 attorney's that the district reached out to. One attorney decided not to submit a proposal due to their work with the City of Cape Coral annexation. Roetzel and Andress, the district's current attorney is working on a proposal and will have it to the District soon. The Board decided to wait until all proposals were submitted so that they could look at them all at once.
- 4. <u>District Name Change Consideration:</u> Attorney Sarah Spector researched the process which would have to be done in order to change the name of the District. Since the District was created by special act, to change the name, it would have to go through legislation. Since this was originally brought forward by Commissioner Hernandez, the board decided to table the discussion until the next meeting.

# New Business:

- <u>Change in date of May workshop and Regular Meeting</u>: Finance Manager Miles explained that the week of the May meeting she and the auditors will be at the FGFOA conference, so in order to have the audit presented and approved in May the meeting would need to be moved to the 5<sup>th</sup> Wednesday. Commissioner Cammick moved to reschedule the May regular meeting from May 22<sup>nd</sup> to May 29<sup>th</sup>. Motion seconded by Commissioner DeLacey. Motion passed unanimously.

for the rebuilding of Station 2 for the minimum award of \$5M. The BOCC will vote at their first meeting in April on who can apply, but if we are selected through this initial process, we would like to try and continue. There was a consensus from the commissioners to move forward, if selected, with the application process.

- Administration is working on a monthly newsletter to send out to our website subscribers and to post on social media.
- We have finally gotten the Equinox in for body repair due to hurricane damage. The cost is covered by insurance.
- The District is hosting our annual Easter Egg Hunt this Saturday.
- Assistant Chief Allen has been working with the crew on bi-annual competencies.
- The "rebuilding together" sign has been replaced at Station 4
- E-154 is in the shop for similar issues to E-152. We hope to have it back in service soon.
- This week is employee appreciation. All three shifts are getting lunch and a tumbler.
- Chief presented a memo about the status of the new bunker gear. Globe has strung us on for some time now and we have gotten to a point where our current gear is going to expire before they can produce the new gear. We have talked to crews and gotten a new quote from a different company who can guarantee the PFAS free gear by when we need it. Commissioner Price moved to cancel the order with Globe and allow the Chief to place the order with Lion. Motion seconded by Commissioner DeLacey. Motion passed unanimously.
- Assistant Chief Davis presented the call report for January 2024.
